Hosting Policy

1. Purpose

The purpose of this Hosting Policy is to ensure a safe, supportive, and enriching environment for international students who are placed in host accommodations through SCOTS English College. This policy outlines the responsibilities and expectations for both hosts and students to foster a positive and effective cultural exchange.

2. Eligibility Requirements

2.1 Host Criteria

- Accommodation: Hosts must provide a clean, safe, and fully furnished room with necessary amenities. Private rooms are preferred, and shared bathrooms must be clean and functional.
- **Location:** Accommodations should be within a reasonable distance from the college or have accessible public transport options.
- Background Check: All hosts must undergo a background check and provide references.
- **Insurance:** Hosts must have appropriate home and liability insurance.

2.2 Student Criteria

- Age: Students must meet the age requirements specified by the college.
- Health and Safety: Students should have appropriate health insurance and meet any required medical clearances.
